

## Patent, Trademark and Copyright Attorneys

Protecting your patents, trademarks, copyrights, and trade secrets abroad can be an important part of your export strategy. Strict time limits apply to filing patent applications in foreign countries and trademark rights in many foreign countries are based on filing rather than use, with the first party to file owning the trademark. It is therefore important to consider these matters.

Most patent attorneys have a network of foreign associate attorneys who handle patent and trademark filings in foreign countries and can advise them regarding copyright protection in foreign countries.
